#### **Terms and Conditions**

The following are the terms and conditions of "The Bishop's 19<sup>th</sup> Annual Catholic Pro-Life Dinner Raffle" which is sponsored and managed by The Catholic Pro-Life Committee of North Texas, Inc. (CPLC).

#### Your participation in the Raffle shall be deemed to be your complete acceptance of the terms and conditions herein.

Entry to the Raffle is available only to persons over the age of 18. You may be asked, at any stage, to provide the CPLC, or a third party, with proof of age and/or identity.

The CPLC's Board of Directors and Officers, and CPLC staff and volunteers directly responsible for conducting the Raffle, shall not be eligible to enter the Raffle.

In order to enter the Raffle each entrant must purchase (or have purchased for him or her) at least one Raffle ticket, at a cost of \$25 per single ticket, \$50 per three tickets or \$100 per eight tickets. The winner of the Raffle is the person named on the ticket that is drawn.

- 4. There are four ways to submit your entry:
  - (a) Mail: Legibly complete the official ticket stub(s) and send by first-class mail, postage paid, along with a check, or required credit card information, to: Catholic Pro-Life Committee, P.O. Box 59852, Dallas, TX 75229. Entrants are discouraged from sending cash, or other forms of negotiable instruments, through the mail.
  - (b) Internet: Access the CPLC website at <a href="www.prolifedallas.org">www.prolifedallas.org</a> ("Raffle Website"), navigate to the Raffle entry page, and complete the Raffle Entry Form by providing all requested information, and then clicking "Submit." When payment is received, the ticket(s) will be filled out with your information and entered in the Raffle.
  - (c) In Person: Obtain your ticket(s) in person from an authorized CPLC volunteer and provide the completed ticket stub(s), along with a check, or required credit card information, to the volunteer. Tickets are available for purchase at the CPLC office, 14200 Midway Road, Suite 120, Dallas, TX 75244, during office hours, 9 a.m. to 4 p.m.

Tickets are also available through local chapters of the Knights of Columbus, Parish Pro-Life Coordinators, other authorized volunteers, and volunteers at the Bishop's Dinner on April 14, 2012, at the Irving Convention Center at Las Colinas.

- (d) Phone: Purchase your ticket(s) over the telephone at 972-267-LIFE (5433) from an authorized CPLC volunteer by providing entry and payment information to the volunteer. The ticket(s) will be filled out with your information and included in the Raffle.
- 5. Prize(s) for winning the Raffle shall be:

1st Prize - \$15,000 American Express Reward Gift Card\*

2nd Prize – Carnival Cruise from Viking Travel

3rd Prize - BlackBerry® PlayBook Tablet

\*Taxes are the sole responsibility of the winner. Winner of the Gift Card Raffle is subject to U.S. withholding tax prior to redemption of prize. The CPLC will furnish the tax documents required for the IRS. The amount equal to 28% of the Prize's fair market value, minus the cost of the Raffle ticket, can either be withheld from the Prize amount or collected from the Raffle winner before the Prize is redeemed.

- 6. The CPLC shall cease to accept Raffle entries on April 14, 2012, when the dinner speaking program begins, at approximately 7:30 p.m.
- 7. The drawing shall take place at the conclusion of the Bishop's Dinner program on April 14, 2012, in this order:
  - 1. 1<sup>st</sup> Prize (ticket to be set aside for announcement at the end)
  - 2. 2<sup>nd</sup> Prize
  - 3. 3<sup>rd</sup> Prize
- 8. The winner of the Raffle Prize(s) need not be present at the drawing in order to win.
- 9. The Prize(s) shall be issued by the CPLC as soon as is reasonable, but at a date no later than 90 days after the drawing to the winner(s).
- 10. The CPLC shall notify the winner(s) via certified mail, or by any available method, within ten (10) days following the Raffle. The winner shall be awarded the Prize as noted in Number 8 above.
- 11. Notwithstanding Section 9 above, in the event that, for any reason whatsoever, the Prize winner(s) fail to respond, within ninety (90) days, to the certified mail notification of his/her winning, such winning entrant(s) shall be deemed to have forfeited his/her claim to such Prize(s) and the CPLC shall not have any obligation whatsoever to compensate the winning entrant in any way. It is at the sole discretion of the CPLC to then conduct a further drawing of ticket(s) from previously sold and retained tickets.
- 12. The CPLC's decision is final with respect to all matters relating to awarding of the Prize(s) and shall not be subject to review or appeal by any entrant or by any third party.

Your participation in the Raffle is deemed your agreement that the CPLC may use your name, likeness or image for promotional and marketing purposes without the requirement for any payment to you, and you hereby grant the CPLC the right to do the same and expressly waive any claims against the CPLC in this regard.
- 14. The Prize(s) is neither transferable nor exchangeable and cannot be exchanged for money or money's worth.
- 15. By entering the Raffle each entrant unreservedly agrees to these terms and conditions which govern the Raffle and the awarding of the Prize(s).

By entering the Raffle each entrant agrees to release, discharge and hold harmless the CPLC, its legal representatives, affiliates, subsidiaries, agencies and its respective officers, directors, employees and agents from any damages whatsoever suffered or sustained in connection with the Raffle or the acceptance of the Prize(s).
- 17. The winning entrant shall be solely responsible for any taxes levied in relation to the delivery or receipt of the Prize(s).
- 18. The CPLC reserves the right to alter these terms and conditions at any time and at its sole discretion.
- 19. The CPLC reserves the right, at any time, to cancel, modify or suspend the Raffle if, in its sole judgment, the Raffle is not capable of being conducted as specified.
